Release, Waiver of Liability, and Indemnification Agreement

In consideration of the right to participate to park cars and trailers north of the MJR Cinema parking lot (Exhibit A), I agree to the following terms of this Release, Waiver of Liability, and Indemnification Agreement (the "Agreement" or "Release").

Waiver of Liability. Participants release and forever discharge and hold harmless Brighton Holdings, LLC, and each of their agents, directors, officers, employees, committee members, volunteers, and assigns (Collectively, "The Team") from any and all liability, claims, and demands of any kind or nature, which exist now or in the future in connection with Participants' use of the parking lot. Participants understand and agree that this Release discharges The Team from any liability or claim that Participants may have against the Team with respect to bodily injury, personal injury, illness, death, property damage, or any other damages or harm that may result from Participants' use of the parking lot, including damages caused by the negligence of the Team. Participants expressly waive any right to a trial by judge or jury that Participants may otherwise have regarding any claim or liability related to Participants' use of the parking lot.

Indemnification and Hold Harmless Agreement. Participants shall indemnify and hold harmless the Team Releasees from and against any and all liability, claims, demands, damages, expenses, fees, fines, penalties, suits, proceedings, actions, and costs of actions, including attorney's fees for trial or appeal, of any kind or nature arising out of or in any way connected with this Agreement or Participants' use of the parking lot, including the conduct of business by Participants, their agents, employees, customers, patrons, or invitees or any act or omission of Participants, their agents, employees, customers, patrons, or invitees.

Broad Release Intended. Participants expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Michigan. This Agreement shall be governed by and interpreted in accordance with the laws of the State of Michigan, and venue for any action arising from this Agreement shall be Livingston County, Michigan. Participants further agree that in the event any clause or provision of this Agreement is deemed invalid, the enforceability of the remaining provisions of this Agreement shall not be affected.


